Remember: Each incorporated city has its own code requirements in addition to the County's requirements. City-specific permits and processes are handled at the respective city level. LAEDC encourages businesses to check with their city planning or community development department first for specific rules. For unincorporated cities, check with L.A. County.

Links to key County websites:

- Los Angeles County Fire Department is responsible for approving all building fire codes.
- **Los Angeles County Department of Regional Planning** performs all land use planning functions for the unincorporated areas of L.A. County. Design quidelines for commercial and industrial projects.
- The Los Angeles County Department of Public Works is responsible for the construction and operation of Los Angeles County's roads, building safety, sewage, and flood control.
 - Los Angeles County Department of Building and Safety enforces building codes and standards to ensure safe building design and construction.
- **County of Los Angeles Public Health** serves Los Angeles County residents and visitors, the food industry, housing and institutions operators, along with water, sewage and solid waste industries.
 - County of Los Angeles Environmental Health assesses environmental conditions and reduces exposure to health risk. Services and Contact Numbers

The Challenge. Along with growing pains of any business, company has been operating for over 4 years at this site. When LAEDC met with this company to provide a business needs analysis, the company was dealing with legal issues which depleted its financial resources and curtailed its ability to borrow additional funds to settle some legal issues.

58 Jobs Saved in the City of Industry

After several business consultations with LAEDC, the LAEDC representative proposed that the company seek procurement contracts with Los Angeles County as a way to increase revenue. Location was key.

It was pivotal that El Tepeyac's location is near the L.A. County Department of Public Social Services Administrative Services office which houses more than 300 employees. El Tepeyac's owners, with the assistance of LAEDC, were able to become a vendor with L.A. County and pursue catering contracts as a local institutional merchant. The strategy was significant in retaining the business and its 58 jobs in the City of Industry.

Need to do Tenant Improvements/TIs?

These are projects that require demolition such as digging and pouring concrete for foundation, support for industrial equipment, racking, storing or building areas for food production. The LAEDC can help steer the way.
