Introduction to the L.A. Stats, 2008 Edition

This is a collection of business and economic indicators for the Los Angeles five-county Area (Los Angeles, Orange, Riverside, San Bernardino, and Ventura counties) and in most instances our neighbor to the south -- San Diego County. A variety of private and public sources have been used in its preparation, and all tables have a citation as to the source.

Los Angeles County is one of 58 counties in the state of California, and has a land area of 4,084 square miles. This area is somewhat smaller than the state of Connecticut. The County contains 88 separate incorporated cities, as well as many unincorporated communities. The County has some unique geographic aspects: 70 miles of coast on the Pacific Ocean; a major mountain range (the San Gabriels), with one peak of 10,064 ft.; and part of the Mojave Desert in the northern portion of the County. The County lies on approximately the same latitude as Atlanta, Georgia, and Dallas, Texas.

Civilian Labor Force Series vs. Industry Employment Series

The civilian labor force (CLF) data and the industry employment (IE) data are both measure employment but are collected differently. The CLF data came from a survey of households **in a given geographic area**. The survey also reports the unemployment rate because it asks for the person's intention on job seeking if the person is currently not working. The survey does not distinguish between full-time and part-time workers, self-employed, and multiple job holders. The IE data is collected by the California Employment Development Department (EDD) **at the place of employment**. This data is more often used as employment indicators because the report has detailed industry breakdowns. Nonfarm employment, a major subset of the industry employment series, is the most commonly used employment indicator.

The two series can diverge for a variety of reasons, including multiple jobs per person, living and working in two different counties, and being self-employed. Thus they should not be compared directly with the purpose of inferring precise information from the divergence of the two series.

Frequently Asked Questions

Why are there more women-owned businesses than the total no. of businesses in L.A. County?

The total number of businesses listed does not include the self-employed or businesses that have no payroll. Many women-owned and minority "businesses" are independent contractors or self-employed.

Section A: County Profiles

Los Angeles County Profile

- **Los Angeles County** (Los Angeles-Long Beach-Glendale Metro Division) covers 4,084 square miles, and had a January 1, 2008 population of 10,363,800 residents; an increase of 844,500 persons since 2000. The County's population would make it the eighth largest state in the nation, just behind Ohio and ahead of Michigan. (California Department of Finance)
- A quick **demographic profile** of Los Angeles County indicates that: 47.3% of the population is Hispanic, 28.8% white non-Hispanic, 14.4% Asian-Pacific Islander, and 9.6% black. About 75% of the population has a high school diploma or more, while 28% has a bachelor's degree or more. (American Community Survey 2007)
- Los Angeles County has a diverse **economic base** (based on the concept of "industry clusters"). Measured by 2007 employment, the leading industries are: 1.) tourism and hospitality with 456,000 workers; 2.) professional and business services with 288,000 workers; 3.) direct international trade with 281,000 workers; 4.) entertainment (motion picture/TV production) with 244,000 workers; and 5.) wholesale trade and logistics with 199,000 workers.
- The "**new economy**" of Los Angeles County is largely technology driven. This cluster includes biomedical, digital information technology, and environmental technology, all of which build on the vibrant technological research capabilities of the County. Another key driver is creativity. There is a growing fusion between technology and creativity such as in video games and film production.
- Los Angeles is the largest **manufacturing center** in the U.S., employing 376,500 workers in 2007. The most important sectors are: apparel with 56,700 workers; fabricated metals with 49,100 workers; food products with 43,000 workers; aerospace products & parts with 38,100 workers; and search, detection & navigation products with 26,987 workers.
- **International trade** is a major driver of the area's economy. The Los Angeles Customs District—which includes the ports of Long Beach and Los Angeles, Port Hueneme, and Los Angeles International Airport—is the nation's largest. The value of two-way trade passing through Los Angeles totaled \$357.3 billion in 2008, compared with \$353.4 billion for second-place New York. Major investments are under way to expand the ports, LAX airport and related transportation facilities in Los Angeles County.
- **Higher and specialized education** is a strength of Los Angeles County, with 112 public and private colleges and universities. These range from UCLA, USC, California Institute of Technology, and the Claremont Colleges to top-rated specialized institutions, like the California Institute for the Arts, the Art Center College of Design, the Fashion Institute of Design and Merchandising, and the Otis College of Art. Medical education is also a strong point; Los Angeles has two each of medical schools, dental schools, and eye institutes, plus specialized research and treatment facilities like the City of Hope. The County's community colleges offer many innovative programs, including culinary arts, fashion design, multimedia, and computer assisted design and manufacturing.
- Los Angeles County's **transportation** network is extensive. In addition to the ports and LAX airport, there are two other busy commercial airports (Bob Hope in Burbank and Long Beach). The freeway system is well-known. In addition, there are many mass transit options including Amtrak, Metrolink (commuter heavy rail), and MetroRail (subway & light rail). Rail freight service is provided by Burlington Northern Santa Fe and the Union Pacific.
- **Quality of life** options are numerous in Los Angeles County. Recreation opportunities range from professional sports to personal recreation at beaches, marinas, and mountain resorts. The number of fine and performing arts activities is growing, as well as special festivals including the renowned Tournament of Roses. Notable landmarks include the Getty Center, Walt Disney Concert Hall, California Science Center and the Staples Center sports arena all in downtown Los Angeles, and the Aquarium of the Pacific in Long Beach.

Orange County Profile

- **Orange County** (Santa Ana-Anaheim-Irvine Metro Division) covers 948 square miles, and had a July 1, 2008 population of 3,126,000; an increase of 280,000 since 2000. This would make the County larger than the state of Iowa and the St. Louis MO-IL MSA.
- A quick **demographic profile** of Orange County indicates that 46.5% of the population is white non-Hispanic, 33.3% is Hispanic, 17.7% is Asian-Pacific Islander, and 1.8% is black. 83% of the population has a high school diploma or more, while 35% have a bachelor's degree or more. (American Community Survey 2007)
- There is a diverse **economic base** in Orange County (based on the concept of "industry clusters") using 2007 average employment as a measure. The leading industries are: 1.) professional & business services with 119,900 workers; 2.) tourism & hospitality with 119,800 workers; 3.) wholesale trade & logistics with 88,500 workers; 4.) direct international trade with 82,800 workers; and 5.) technology with 79,800 workers.
- **Technology** is a vital force in the Orange County economy, with several "clusters" of activity, including Irvine (around both the Spectrum and UC Irvine), and in the mid-county area. Areas of emphasis include computer software, semiconductors and bio-med applications.
- Orange County is also a **major manufacturing center**, with 151,000 workers in 2007. This puts the County just behind Seattle-Tacoma (156,303) and ahead of Cleveland (144,773). The largest sectors are: computer & electronic products with 31,200 workers; fabricated metal products with 24,600 workers; medical equipment & supply with 12,000 workers; machinery with 11,000 workers and aerospace products & parts with 10,900 workers.
- Orange County businesses have been very aggressive in **international trade**, and utilize the ports of Long Beach and Los Angeles, as well as Los Angeles International Airport, LA/Ontario International Airport, and other support activities.
- The **higher education assets** of Orange County are extensive, including the University of California-Irvine (which has a medical school), California State University Fullerton, Chapman University, and the Southern California College of Optometry. There are also several well-regarded community colleges.
- **Transportation** service in Orange County is well developed. Besides the freeway system, there is rail mass transit with service by Amtrak and Metrolink, and bus service offered by the Orange County Transit Authority. Commercial air service is offered at Orange County-John Wayne Airport.
- **Quality of life** is a strong point for the County, with nearly 40 miles of coast line and three small craft harbors. The mountains on the east side of the county offer outdoor recreational opportunities. An array of fine and performing arts opportunities include the Orange County Performing Arts Center in Costa Mesa, plus professional baseball and ice hockey. The modern theme park was born at Disneyland in Anaheim, which now includes a second park called California Adventure that's geared toward a more mature audience. Knott's Berry Farm and its sibling, Soak City USA are also located in Orange County.

Riverside-San Bernardino Area Profile

- The Riverside-San Bernardino-Ontario Metropolitan Statistical Area is comprised of Riverside and San Bernardino counties, and is often called the "**Inland Empire**." The area is bordered by Los Angeles and Orange counties on the west, and on the east by the states of Nevada and Arizona. Riverside County covers 7,304 square miles while San Bernardino covers 20,106 square miles. The July 1, 2008 **population** of the area totaled 4,167,000 persons; an increase of 913,000 persons since 2000. The area's population count would make it larger than Puerto Rico, the state of Oregon and the Seattle-Tacoma-Bellevue, WA MSA.
- A quick **demographic profile** of the counties indicates that in Riverside, 42.7% of the population is white non-Hispanic; 43.2% is Hispanic; 6.0% is black; and 5.3% is Asian-Pacific Islander. In San Bernardino, 36.2% is white non-Hispanic; 46.8% is Hispanic; 8.4% is black; and 5.9% is Asian-Pacific Islander. As to education, 80% of Riverside County's population has a high school diploma or higher, and 20% has a bachelor's degree or higher. For San Bernardino, the numbers are 77% and 18%, respectively. (American Community Survey 2007)
- There is a diverse **economic base** in the Inland Empire (based on the concept of "industry clusters"). Using 2007 average employment as a measure, the leading industries were: 1.) tourism with 96,600 jobs; 2.) direct international trade with 90,400; 3.) professional & business services 55,600; 4.) wholesale trade & logistics with 48,900; and 5.) health services & biomedical with 37,500.
- The Inland Empire is also a growing **manufacturing center** with employment at the 87,000 mark as of 2007. The largest components are: fabricated metal products with 15,700 jobs; automotive manufacturing with 14,600; food, beverages, and tobacco products with 10,600; plastic products with 9,500 and furniture & home furnishings with 7,400.
- The **international trade** aspect of the Inland Empire's economy is extensive. The area is a major transportation hub for both rail and truck service, has the LA/Ontario International Airport (a UPS hub, both small packages and air freight, and for Asian service), and is a major distribution center for firms moving goods through Southern California's ports to the rest of the U.S.
- This area has an impressive array of **higher education** facilities, including the University of California-Riverside, Cal State San Bernardino, University of Redlands, and the Loma Linda School of Medicine. Just to the west of the county line in L.A. are the Claremont College group and Cal Poly Pomona. There are also several community colleges.
- As noted above, the Inland Empire is a hub for **transportation services** in Southern California. There is the LA/Ontario International Airport, strategic freeway access, two rail lines, and service by Amtrak and Metrolink (3 lines). There are also three ex-military air fields that are being redeveloped for commercial use: George Air Force Base as the Southern California Logistics Airport, Norton AFB as the San Bernardino International Airport, and March AFB as the March Inland Port.
- The two-county area has a diverse portfolio of **quality of life** elements. These include desert resorts with championship golf courses, and mountain resorts that offer skiing in the winter. The Coachella Valley has several Indian casinos. There are also fine and performing arts. The California Speedway in Fontana is the largest auto racetrack in Southern California.

Ventura County Profile

- **Ventura County** (Oxnard-Thousand Oaks-Ventura, CA Metropolitan Statistical Area) covers 2,208 square miles, and had a July 1, 2008 population of 830,300; an increase of 77,000 since 2000. The County's population is slightly larger than that of the state of South Dakota and of the Albuquerque, NM MSA.
- A quick **demographic profile** of Ventura County indicates that 52.6% of the population is white non-Hispanic, 36.7% is Hispanic, 6.6% is Asian-Pacific Islander, and 1.7% is black. 82% of the population has a high school diploma or more, while 30% has a bachelor's degree or more. (American Community Survey 2007)
- Ventura has a diverse **economic base** (based on the concept of "industry clusters) using 2007 average employment as a measure. The leading industries are: 1.) tourism and hospitality with 19,000 workers; 2.) wholesale trade & logistics with 14,500 workers; 3) health services & biomedical with 13,800 workers; 4.) direct international trade with 13,700 workers; and 5.) professional & business services with 13,300 workers.
- There is a significant cluster of **new technology** activities in Ventura County, with a concentration around Camarillo. Bio-med giant Amgen is based in Thousand Oaks.
- There is also an **international trade** component to the County's economy, due to Port Hueneme. This is a "break-bulk" facility that handled 3,970,700 tons of cargo in 2007. The major commodities are cars, and fruit and vegetables.
- On the **higher and specialized education** front, there are California Lutheran University and several community colleges. The new California State University-Channel Islands opened in Camarillo in 2002 and is rapidly expanding its programs.
- Besides Port Hueneme and the freeways, Ventura County has **transportation** service by both Amtrak and Metrolink. Commercial air service is available at Santa Barbara to the north, or Burbank Airport and LAX in LA County.
- **Quality of life** is a strong suit for Ventura County. It has about 40 miles of coast line, including two small craft harbors. There is Lake Casitas, the famed Ojai resort area, plus the Los Padres National Forest. There is still a significant agricultural presence in the County, which provides an unusual ambiance.

San Diego County Profile

- **San Diego County** (San Diego-Carlsbad-San Marcos, CA Metropolitan Statistical Area) covers 4,526 square miles, and had a July 1, 2008 population of 3,161,000; an increase of 347,000 persons since 2000. The County's population would make it slightly larger than the St. Louis MO-IL MSA and the entire state of Iowa.
- A quick **demographic profile** of San Diego County indicates that: 29.9% of the population is Hispanic, 51.6% is white non-Hispanic, 10.4% is Asian-Pacific Islander, and 5.0% is black. 85% of the population has a high school diploma or more, while 33% has a bachelor's degree or more. (American Community Survey 2007)
- There is a diverse **economic base** in San Diego County (based on the concept of "industry clusters"). Using 2007 average employment as a measure, the leading industries were: 1.) tourism with 110,800 workers; 2.) professional & business services with 86,400 workers; 3.) technology with 60,600 workers; 4) wholesale trade & logistics with 57,600 workers; and 5.) health services & biomedical with 47,800 workers. The military is also a major force in the County's economy, accounting for nearly 4% of its employment.
- The "**new economy**" of San Diego County is technology driven, and includes bio-med, communications, and computer science. These sectors build on the vibrant technological research capabilities of the County's business base and UC San Diego.
- San Diego is a large **manufacturing center** in the U.S., with 76,700 workers in these activities in 2007. The largest components were computer & electronic products with 16,500 workers and machinery manufacturing with 7,600 workers. San Diego also has the only large shipbuilding industry on the West Coast.
- **International trade** is a major component of the area's economy. The "San Diego Customs District" is a major channel for U.S.-Mexico trade. In 2008, total two-way trade at the customs district reached \$54.0 billion, with Mexico accounting for \$4.5 billion or 82.5%.
- **Tourism** is a major source of income for San Diego County. Besides its own tourist attractions such as the SeaWorld, San Diego Zoo, Wild Animal Park, and Legoland, San Diego also benefits economically from travelers going to and from Mexico. Several cruise ships also set sail or make port calls at San Diego.
- **Higher and specialized education** is a strength of San Diego County, with 64 college and university campuses, including University of California, San Diego (UCSD). UCSD is credited as a major driving force behind the region's technology industry. San Diego State University and Cal State San Marcos also make significant contributions to the region.
- **Transportation** service in San Diego County is extensive. There is a major commercial airport -- San Diego International Airport (a.k.a. Lindbergh Field) -- with domestic service and international flights to Canada and Mexico. Besides the freeway system, there are also heavy rail services including Amtrak, Metrolink (connecting Oceanside with Los Angeles, Orange, Riverside, and San Bernardino counties), and the "Coaster" (between Oceanside and San Diego). The San Diego Trolley (light rail) serves much of San Diego City. Rail freight service is provided by BNSF.
- San Diego County is home to several **military bases**, including Camp Pendleton (Marines), Miramar (Marines Corp aviation), and several naval stations for ships, submarines, and naval aviation. San Diego is also the home port of the U.S. Third Fleet, which covers the Eastern Pacific Ocean. Direct DoD spending accounts for over 9% of San Diego's economy.
- **Quality of life** options in San Diego County are numerous. These range from professional sports to personal recreation at beaches, marinas, and mountain resorts. The 1,200-acre Balboa Park, a large urban park in the heart of San Diego, is home to several museums and the San Diego Zoo. The SeaWorld, the San Diego Zoo and Wild Animal Park attract visitors from near and far, and Legoland California is a perennial favorite among children. There is a growing array of fine and performing arts activities, as well as Indian gaming facilities.
