A MESSAGE FROM LAEDC's CEO

We are pleased to report on LAEDC's activities for the fiscal year ended June 30, 2017 (FY 16-17) and highlight results made possible by the generous support of the County of Los Angeles and our members and partner organizations. During the year, LAEDC delivered many successful programs and initiatives to advance economic opportunity and prosperity for all L.A. County residents.

LAEDC's Business Assistance Program attracted or retained 20,460 jobs for area residents during the fiscal year, bringing to 226,865 the number of jobs directly retained or created in L.A. County since the program began in 1996, as reported by the employers who have utilized our free services. These direct jobs also lead to indirect and induced jobs, so that a tremendous number of L.A. County residents are able to provide for themselves and their families as a result of this award-winning program.

Funding from the County of Los Angeles alongside our members and partners is vital to LAEDC's mission, which was established by the County in 1981 to leverage County investment with that of the private sector to achieve strategic economic objectives for the health and well-being of county residents. In FY 16-17, private funding comprised about 47% of LAEDC's operating budget. This not only helped fund our Business Assistance Program

to strengthen small businesses and enable job creation, but it also made possible important economic research on our region's key employment clusters and labor force characteristics, and supported the World Trade Center Los Angeles, which fosters job creation by attracting foreign investment and promoting exports from local manufacturers.

In addition, the 2016-2020 L.A. County Strategic Plan for Economic Development became fully operationalized with the hiring of a Director and three full-time support positions dedicated to helping implement and track the plan's 7 goals. While the development and operationalization of this plan was funded by LAEDC's ability to raise separate dedicated philanthropic funds for this initiative (now branded as Propel L.A.) the forward-thinking strategies within the plan enable a broad coalition of countywide stakeholders to build on our region's strengths to create a stronger, more sustainable and more inclusive economy for LA County's 10.2 million residents.

We thank the County of Los Angeles and all our members and partners for this long standing and mutually beneficial partnership with LAEDC, which serves as one of the region's most effective tools for addressing poverty, income inequality and social mobility.

BUSINESS ASSISTANCE PROGRAM

LAEDC's Business Assistance Program (BAP) multi-lingual team provides confidential and no-cost business assistance and advisory services to small, medium and large businesses in over 16 industry sectors as well as to the County itself and the 88 cities, to attract, retain and expand businesses, jobs and investment.

The BAP Team works closely with County, cities and state-wide economic development and workforce development partners. BAP regional managers work one-on-one with companies that want to locate in L.A. County, identifying short and long term needs and provide action plans to help businesses overcome challenges and opportunities.

LAEDC closed FY 16-17 with a historical BAP program total of 226,865 direct jobs created and/or retained in L.A. County. Principal accomplishments for FY 2016-17 alone were:




INDUSTRIES OF JOBS SAVED

With L.A. County's diverse economic base, the jobs saved through these retention efforts occurred across a variety of industries. Almost two-thirds of the jobs saved (5,380) were in manufacturing industries. Health care and social assistance industries accounted for an additional sixteen percent of all jobs saved. The remainder were distributed among several other industry sectors. The distribution of the BAP jobs saved shows the variety of industries impacted by the efforts of the program.

LA COUNTY'S LAYOFF AVERSION CONTRACT WITH LAEDC

In addition to the Social Program Agreement, LAEDC provides Layoff Aversion program services to at-risk companies in the County Workforce Development Board's service delivery area through a contract with L.A. County Community and Senior Services (CSS).

LAEDC's BAP Team provided critical information on no-cost federal, state and local business assistance programs, resources and services to firms throughout L.A. County through a targeted informational outreach campaign with over 9,597 firms through emails, personal phone calls and mailings.

WORLD TRADE CENTER LOS ANGELES



World Trade Center Los Angeles, LAEDC's affiliate, continued its focus on both attracting Foreign Direct Investment (FDI), and helping our local firms increase export and trade opportunities. This focus continues to improve our regional economy and creates well-paying jobs for LA County residents. During FY 2016-17, LAEDC subsidiary World Trade Center L.A. achieved significant milestones in their work to bring Los Angeles to the global market. They published their *Foreign Direct Investment* (FDI) report to quantify the importance of global connections to jobs in L.A. County and hosted the very successful Select L.A. Investment Summit. They also launched a social media campaign highlighting the economic contributions of Foreign Owned Establishments (FOEs) to our region, and built on their already robust website be adding a new GIS mapping feature that allows users to view an interactive map of all the FOEs in the region.
