INTRODUCTION FROM WORLD TRADE CENTER LOS ANGELES

2020 was an unprecedented year for the international economy. The COVID-19 pandemic upended all aspects of life and dramatically reduced trade flows across the world while public health orders and business restrictions forced the closure of countless establishments and sent unemployment rates skyrocketing in the United States. Alongside major declines in global production and economic growth came a deterioration of foreign direct investment, as many new greenfield projects, mergers and acquisitions were shelved or cancelled. With governments focused on keeping their companies and citizens afloat and building out recovery strategies, the duration of the health crisis and growing protectionist sentiments may influence the future landscape of international trade and investment.

Though the United States remains in the midst of this pandemic, the introduction of a new foreign policy agenda under President Biden's direction has the potential to revitalize strained relationships with allies and welcome renewed cooperation. The Biden Administration has outlined a plan that aims to protect American workers and farmers while also engaging with global trading partners multilaterally and confronting unfair trade practices. The trajectory of foreign direct investment remains unclear in 2021, as a wide range of economic, health and political forces are currently at play.

This report on foreign direct investment in California, presented by the World Trade Center Los Angeles (WTCLA) and Los Angeles County Economic Development Corporation (LAEDC), represents the sixth edition of our annual outlook. In keeping with our previous edition, we estimate FDI across the entirety of California's regions alongside our focus on Los Angeles County.

This year's WTCLA FDI report also evaluates the key contributions that place branding can have on attracting investment flows to California. In collaboration with the David Nazarian College

of Business and Economics at CSU Northridge, WTCLA's report highlights how place branding can build associations with foreign-owned establishments (FOEs) and create a strategic advantage for California when attracting new investment. Additionally, a state comparison between California, New York and Texas measures employment and industry mix of FOEs. Lastly, the analysis compares FOE business type in California by region and industry, showing the stock of companies that use the state as their headquarters, subsidiaries or branches.

In 2020, there are an estimated 18,451 foreign-owned firms operating in California. These FOEs are estimated to employ 703,187 residents, who earned an estimated \$64 billion in wages last year. The impact of the pandemic on FDI numbers is clear, as in 2020 there were 27,461 less California residents employed by FOEs than in 2019 and 267 less firms. Some countries decreased their presence dramatically, such as the United Kingdom and Canada with over 10,000 less employees in California than the year prior. Others became larger contributors as the Netherlands and Ireland added over 2,000 workers each. By industry, retail trade had the greatest year-over-year growth with 9,500 jobs and 460 firms added in California, as financial activities, information and wholesale trade all suffered significant losses.

Japan remains the leading source nation - or the country from where the investment originates of foreign direct investment in California with 3,672 establishments employing over 115,000 California residents while contributing \$10.6 billion in wages. The United Kingdom, France, Germany and Switzerland round out the top five source-countries of FOEs in the state. Once again, the ten counties of Southern California command the majority of the state's FDI with 60.5 percent of all Californian FOEs and 63.2 percent of all Californian FOE employment. The Bay Area's fifteen counties account for roughly 31 percent of foreign establishments and employment, and the remaining 23 counties of the Greater California region account for the rest.

REGIONAL BREAKDOWN

This year's FDI report continues to include data on all of California to analyze the diversity and concentration of FOEs throughout the state. The breakdown of the State of California into three distinct regions is illustrated in the adjacent map. Based on best practices and historical regional definitions, the Bay Area region southern and northern boundary is Monterey County and Sonoma County, respectively, with the eastern boundary formed by the counties Merced, Stanislaus and San Joaquin. Southern California includes all counties south of Monterey, Kings, Tulare and Inyo. All other counties in the state are considered Greater California.

STATE COMPARISONS AND FIRM-TYPE BREAKDOWN

The following two pages discuss the importance of place branding and how it can influence consumer choice and attract foreign direct investment. A comparative analysis of employment between top FDI states in the U.S. is presented to show California's competitive advantage and potential for successful place branding. The following section highlights FOE business type throughout the state by region and industry and the shifts in their composition from 2020 to 2021.


FDI AND PLACE BRANDING

Place branding refers to marketing activities to promote a positive place image in order to influence consumer's destination choice, increase exports, and attract foreign direct investment. Colorado's "Come to Life" brand and Mississauga brand are two prominent examples of place branding around the world, which increase visibility and reputation for the locations, help attract foreign travelers and investors, and stimulate local economic development. Branding California and Los Angeles as an FDI destination to foreign investors could be a worthwhile consideration for both local and state government agencies as the global marketplace is fiercely competitive. California has shown its position as an FDI destination for foreign investors. Based on the FDI-related statistics offered by the U.S. Bureau of Economic Analysis (BEA), California is the number one state in terms of the number of employees employed by FOEs, followed by Texas and New York (Chart 1). These three states also represented over half of all FOE employment in the United States from 2007 to 2018. This could be considered as one of California's competitive place branding advantages since extant literature on FDI shows that foreign investors found more success in regions where the proportion of foreign owned businesses are higher. As foreign businesses seek to gain a foothold in the U.S. market, policy makers in California could differentiate California from other states by showing its competitive advantages for FDI and the values California can offer to foreign investors.

A place brand embodies a unique image of the place among stakeholders' minds, showing its unique value propositions to its consumers, local business, and other stakeholders. In the context of FDI, California can be considered a place brand with a unique image as the FDI destination in the U.S., while Los Angeles County can be branded as the FDI destination in Southern California. As the place brand increases the favorability of the location, attracting foreign investors and bringing more job opportunities to residents, public policy makers might want to promote the place brands in a more proactive way. A place brand can be developed and promoted by activities such as building associations with its customers (i.e. FOEs) and delivering long-term competitive advantages of the place. One key aspect of place branding is to establish a strategic orientation of a place to show its competitive advantages. The BEA and FOE data can be used as a way to identify the strategic orientation of place brands for California, different regions of California, and Los Angeles County by focusing on the critical industry sectors concentrated in each region.

The BEA data (Chart 2) indicates that manufacturing, wholesale trade, retail trade, and information are the top industries for FOEs in California in terms of the number of employees

CHART 1: TOP 3 STATES BY SHARE OF FOE US EMPLOYMENT (IN THOUSANDS OF EMPLOYEES)



employed by FOEs, which stayed the same from 2013 to 2018. These FOE concentrations show California's unique position in these industry sectors compared with other states in the U.S., which could be considered another competitive advantage of California as a place brand of the FDI destination in the U.S. As the location of a headquarters or parent business is critical to FOE's business development and job creation, this change reflects the potential value of California as a FDI place brand for FOEs despite of the adverse impact of COVID-19 pandemic on foreign businesses in the U.S. The following tables show the regional distribution of headquarters/parent businesses by industry in 2020 and 2021, as well as the changes, showing that the Bay Area leads in services while Southern California attracted a larger percentage of headquarters/parent businesses in manufacturing and wholesale trade. By contrast, the headquarters FOEs in Greater California had the largest increase from 2020-2021 (11.1%), especially in transportation/communications/utilities and financial services/insurance/real estate.






























