#### April 21st, 2023

#### **Meeting Presentation**

#### **Grant Funding Status / Research Reports**

- Charles Johnson, Program Director for Community Economic Resilience Fund, welcomes new partners and gives updates on the status of the grant. The Fiscal Agent will be releasing \$5 million in two tranches.
  - LAEDC will receive an advance payment in the first distribution to pay for salaries, CRM, website development, and research reports on labor market analysis, industry clusters and environmental impacts. These reports will help inform strategic decisions on which projects to invest in and industries to target.

  - Current state of L.A.'s job market
  - Ethnic survey for race-based geo recovery & transition strategy post pandemic
- Report #2 Industry Cluster
  - Analysis of trends and growth
  - Where the good paying jobs will be

  - Assessment of Climate Change
  - Analysis of emerging industries
- Partners suggest including ethnic data in the survey data for planning purposes. LAEDC specializes in providing research data and industry cluster analysis on high growth sectors such as aerospace, healthcare, trade and logistics etc., encouraging partners to consider aligning their projects with these sectors during implementation phase.
  - Tony representing the American Indian Chamber of Commerce, California. When you're doing your labor market analysis, it might also be helpful to understand where the dominant emerging industry sectors are by race and ethnicity so that we can be thinking about how we create those on-ramps to the high wage, high-road jobs. Because it may be that for certain groups that are not currently active in a clean tech market, but that doesn't mean that they aren't in occupations that with the right type of workforce training could be transitioned. So not just dominant emerging, but dominant emerging by race and ethnicity.
  - Sharon regarding the ethnic survey in Scope 1 that is included in that RFP content, we ask that we have some collaboration to ensure that the actual lived experience data that will be flowing from our community organizations that will be capturing ethnic data flows get summarized in that scope of work. Because we don't want it to just be statical data-based information, on historical or any other information, but we want to make sure our communities have a voice and they're actually heard. Reaching into communities flows that information into our planning process.

#### **Potential Industries of Focus:**

Jermaine Hampton of LAEDC discusses the purpose of the CERF initiative, which aims to better communities and move towards a carbon neutral economy. The focus is on sustainability, energy, and green jobs in various sectors such as trade and logistics, advanced transportation, and innovative small businesses. There will be research RFPs to analyze these sectors more indepth. Feedback from community members is encouraged to make sure that planning aligns with all available information.

- Susan Park speaks up about the need for more outreach in language to AAPI communities regarding these programs.
- Participants discuss the importance of language accessibility and translation in outreach efforts. Hyepin Im suggests using ethnic media as a resource for translation and communication with diverse communities.

- The group discusses upcoming due dates for planning phase plans and program deliverables.
  - May 1<sup>st</sup> Planning Phase Plan due Outlines the structure and expenses of the program in order to conduct the inclusive regional economic planning process.
  - June 6<sup>th</sup> Final Governance Structure Due- outlines the structure and election process.
  - July 6<sup>th</sup> Governance Seating Due
  - August 31<sup>st</sup> Regional Summary Part 1 Due Research snapshot and analysis
  - August 30<sup>th</sup>, 2024 Regional Plan Part 2 Due
